Bookings will only be confirmed once full payment has been received and the information form completed. If the information form is not completed correctly, the corresponding order will be cancelled automatically.

By completing the information form, you are informed and agree that the information provided is proof of your identity and your commitment to purchase. Information collected by SPORTEL Awards may be used as proof of all financial transactions carried out when booking.

SPORTEL Awards reserves the right to amend these General Terms & Conditions at any time and without notice. In this case, SPORTEL Awards will send you the new General Terms & Conditions by email.

After each order has been placed, SPORTEL Awards will systematically send email confirmation.

The confirmation email must be kept and shown to access the Boxing Gala at the Fairmont Monte-Carlo, Salle d'Or, on Tuesday 5th October from 21:30.

## 5. PAYMENT
